Applicant hereby pays five dollars (\$5.00) which will constitute Applicant's membership fee if Cooperative accepts this application; in the event Cooperative does not accept this application, the membership fee shall be returned to Applicant. Applicant also pays the security deposit required by the Rules and Regulations of the Cooperative.
2. Applicant will purchase all electric energy used on the premises described in this application and will pay for all electric energy used on the premises each month at rates that are approved by the Board of Trustees.
3. Applicant will, if accepted as a member, comply with and be bound by the Bylaws and Rules & Regulations of the Cooperative.
4. Applicant will cause the premises being served to be wired in accordance with wiring specifications as set forth by the National Electric Code. Applicant hereby acknowledges that the Cooperative will not be required to inspect said wiring and will not, in any manner, be liable for any defects therein or for any damage resulting from such defects in wiring.

Cooperative agrees to furnish services to said lands and premises as Applicant may require, provided however, should an energy crisis, or Cooperative's inability to obtain such amount of electricity desired by Applicant and Members of the Cooperative, Cooperative shall not be liable to Applicant. It is further provided that Cooperative does not guarantee uninterrupted service to Applicant and shall not be liable for any loss or damage sustained by Applicant for any interruption in service not directly caused by the gross negligence of Cooperative.

The acceptance of this application by Cooperative shall constitute an agreement between Applicant and Cooperative that shall continue in force from the date service is made available and thereafter until terminated by either party in accordance with the Bylaws and Rules and Regulations of the Cooperative.
